### **What type of personal information do we collect?**

Personal information you disclose to us:

*In Short: We collect personal information that you voluntarily provide to us when you register.*

Personal information provided by you:

We currently collect and process the following information:  
names; phone numbers; emergency contact, email addresses; mailing addresses; contact preferences; additional information about the child e.g., allergies; and other similar information.

All personal information that you provide to us must be true, complete and accurate, and you must notify us of any changes to such personal information.

### **Why do we collect the personal information provided by you?**

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- various contact details in case of accident or injury
- failure to collect a child from our care,
- the sharing of medical information to ensure the safety and well-being of the child

We also receive personal information indirectly, from the following sources in the following scenarios:

- An additional emergency contact in case of not being able to contact the parent or guardian stated on our Health and Safety form.

### **How do we use your information?**

*In Short: We process your information for purposes based on legitimate business interests, the fulfilment of our contract with you, compliance with our legal obligations, and/or your consent.*

We use personal information provided by you for a variety of business purposes described below. We process your personal information for these purposes in reliance on our legitimate business

interests, in order to enter into or perform a contract with you, with your consent, and/or for compliance with our legal obligations. We indicate the specific processing grounds we rely on next to each purpose listed below.

We use the information we collect or receive:

- To post testimonials. We post testimonials on our website that may contain personal information. Prior to posting a testimonial, we will obtain your consent to use your name and the content of the testimonial. - Request feedback. We may use your information to request feedback and to contact you about your use of our website.

**How do we store your personal information?**

*In short: Your information is securely stored.*

We keep the information you provide on our Health and Safety form for the duration of time your child wants to attend Yoga Play for Kids sessions. We will then dispose of your information by shredding or deleting the form.
